Westhill Central School is committed to supporting their students and the one-to-one learning environment in all of their buildings. To do this they are constantly challenged to upgrade and support their network infrastructure. With this supplemental application they wish to upgrade the battery back up on the network closets. These closets are critical to the switching infrastructure and the file servers that the students depend on. They are also critical to the Voip phone system and the security cameras and door controls. The UPS support makes sure that these systems operate even when the district experiences a brief power

interruption. The phones will continue to work, the cameras continue to work, and the door security also continues to work. The second component of the application is to replace several antiquated wireless access points. The district regularly reviews the network infrastructure and they have identified a few access points that need to be upgraded. The district is committed to a one-to-one wireless network and these devices will make sure that students are able to accomplish their tasks and reach their goals.

Westhill Central School employs a District Technology Director and several full and part time technicians. On a regular basis this team meets with the planning specialist from CNYRIC and the academic leadership of the district. This group reviews the academic expectations for all education spaces and the number of students relying on the network resources in that space. This team then identifies any upgrades or replacements that are required for the IT network to meet the academic goals.
